PART 4 - Stand Build Conformity

This section must be completed in FULL by all Space Only Exhibitors or their contractors. This section MUST be completed in full in order for permission to build to be issued.

It is compulsory to submit full elevation and dimensional plans for your proposed stand build. Thorough checks will be carried out to ensure the stand conforms to all stand build regulations however completing the following section will assist in this process.

1	What is the construction height of the stand?
2	What is the height of the raised floor and depth of the ramp?
	Must conform to the following: raised floor from 1mm to 20mm: this must have a ramped edge raised floor from 20mm to 40mm: cut-off corner twice the height of floor as previously more than 40mm: not permitted Please note this rule does not apply to portions of the stand closed by installations integrated into the floor which would make direct access to stand impossible i.e reception desk, low height walling.
3	Are any parts of the stand covered? (ie. false ceiling, muslin, beams) Please submit a separate plan detailing the material to be used and the dimensions including the thickness; these will need to conform to section 4.3 of the venue regulations.
4	Are you enclosing any open sides of your stand? Please note you are only permitted to wall one third of any open side of the stand however this will not be permitted if the number of fire exits required for the space cannot be achieved. Please refer to paragraph 3.3 of the venue regulations for more information.
